- 1. Title(s) and date of the film(s), television property(ies) or description of stills that are requested.
- 2. Detailed information describing what material you wish to use.
- 3. Detailed information of exactly how the material will be used.
- 4. Type and purpose of the project or program in which you propose to include the material.
- 5. For Feature Film or Television use, please include a synopsis of the script and relevant script pages illustrating how the material is to be used.
- 6. For Publishing use, please include the associated text and the relevance of the material to it.
- 7. The number of clips you wish to use along with a description and the length of each clip.
- 8. Distribution of your production including media, territory, length of term, broadcast date, etc.
- 9. Name of the copyright holder, if different from your company.
- 10. Contact information including a phone, fax number and e-mail address. If you are calling from outside the United States or Canada, provide the international access code for your country and city.
- 11. Any additional questions or concerns.
- 12. Fees are set according to use, which are subject to review and approval of the request.
